Purpose: To outline the qualifications for promoted positions

Scope: This policy applies to all uniformed members of the Fire Department

Directions:

1. An employee may not test for a position without all of the qualifications
2. Promotions must be in the following order:
 1. Firefighter
 2. Engineer
 3. Captain
 4. Battalion Chief
3. Testing must follow the same order as the promotions.
4. Firefighter Testing will be an oral interview panel and subsequent Human Resource Testing.
5. Engineer Testing will include a written test and a pass/fail field pumping evolution and an interview.
6. Captain Testing will include a written test, Human Resource Assessment, Tactical Assessment and oral interview.
7. Battalion Chief and Deputy Chief Testing will include a Human Resource Assessment, Tactical Assessment, oral interviews and other testing as required and appropriate for the position.
8. Personnel will not be able to cross over from divisions without filling the appropriate positions below the position sought. Positions are not equitable in experience from one role to the next.

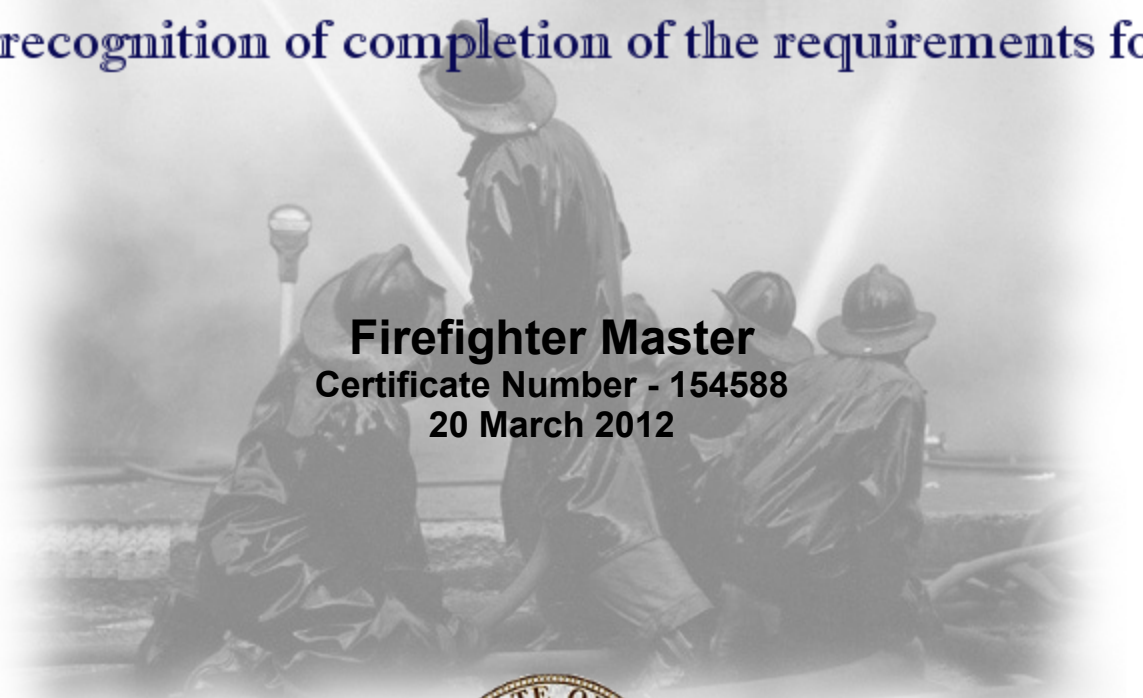
