SOG# 02-01 – Emergency Response (Tiered Responses)	Effective Date: 10/31/2005
Fire Chief: 	Revised Date: 10/1/2013



Purpose: To maintain personnel and public safety during emergency responses.

Scope: This policy applies to all members that respond to emergency events.

Directions:

1. All calls for service will be classified as an emergency or a non-emergency. Further, emergency responses will either be classified as a Code 1 or a Code 3 response and will utilize the appropriate warning devices based on the call classification.
2. The following calls are emergency calls for service that will justify a Code 3 response:
 - a) Structure Fire
 - b) Vehicle Fire
 - c) Grass Fire
 - d) Dumpster Fire
 - e) Miscellaneous Fires
 - f) Transformer or Other Electrical Equipment Fire
 - g) Commercial Fire Alarm(s). First Due only Code 3
 - h) Motor Vehicle Accident with Injuries
 - i) Powerlines Down
 - j) Smell of Gas inside a Structure
 - k) Medical Emergency
 - l) Commercial Fire Alarm with Multiple Activations
 - m) Medical Alarms
 - n) Child(ren) Locked in a Vehicle (House)
 - o) Residential Fire Alarms/Smoke detector activation with smoke (or smell)
 - p) Public Assist Involving a Fall or Entrapment
 - q) Technical Rescue
 - r) Mutual Aid to the Scene
 - s) Carbon Monoxide Detector Activation
 - t) Water Vac. First Due only Code 3
 - u) Elevator Rescue. First Due only Code 3

EMS Code 3 response calls for service will have a performance objective of 60 seconds for turnout time and 270 total seconds for initial arriving ALS unit.

Fire and Rescue Code 3 response calls for service will have a performance objective of 80 seconds for turnout time and 390 seconds for initial arriving apparatus.

3. The following calls are emergency calls for service that justify a Code 1 response:
 - a) Commercial Fire Alarm with Single Activation Move to Code 3 for the district or First Due.
 - b) Water Vac District Engine will go Code 3
 - c) Pet Locked in a Vehicle
 - d) Vehicle Locked and Motor Running
 - e) Public Assist Involving Moving a Patient
 - f) Residential Smoke Detector Activation Without Signs of Fire
 - g) Elevator Rescue Moved to Code 3
 - h) Smell of Gas outside of any structure
 - i) Assist Police or Other Agency Assistance call
 - j) Mutual Aid Fill-In

4. All Emergency Code 3 calls for service can be downgraded to a Code 1 response once a unit is on the scene and has determined that the urgency of the incident can be handled by that single company. Additional resources may still be required, but without urgency.

5. On Structure Fire Responses, an “ALL CLEAR” or “NO ALL CLEAR” must be issued prior to the down grading of the response.

6. On Medical Emergency Responses, if the patient does not require immediate transport, the incident can be downgraded.

7. On MVA incident s TIMS should be established prior to downgrading the response.


8. Any Chief or Company Officer is responsible for making the ultimate decision on downgrading or upgrading a response.

9. The Communications Center should be notified if a response is downgraded or upgraded.

10. Communications personnel are authorized to upgrade an assignment based upon information received in the Communications Center.

11. On all Fire Alarm calls that get cancelled en route the in District Engine shall proceed to the address and verify the false alarm.

Purpose: To outline the apparatuses for each type of response

Scope: This policy applies to all members of the Operations Division

Directions:

1. Each call for service will dictate a particular apparatus or group of apparatus for response.
2. The company officers and chief officers have the authority to reduce or increase any call for service.
3. Communications personnel are authorized to upgrade an assignment based upon received information in the Communications Center.
4. There are three classifications of response within the fire department: 1) Single Company Assignment; 2) Special Assignment; and 3) Full Assignment.
5. A Single Company Assignment is an incident that consists of a single company responding to an event. The apparatus can be an MICU, engine, truck, rescue or chief officer.
6. A Special Assignment is an incident that consists of two companies or more, but not enough to constitute a Full Assignment. The assignment can be an MICU and Engine, a Chief Officer and an engine, 2 engines and a truck, a rescue and a truck, a truck and chief officer, or other combinations, less than a Full Assignment.
7. A Full Assignment is an incident that consists of 3 engines, a truck, 3 MICUs and a chief officer.

8. In accordance with *Coppell Fire Department SOG #02-01 Emergency Response*, the following calls will originally be dispatched as a Single Company Assignment with an engine dispatched (a truck can be used if an Engine is not available):
 - i. Dumpster Fire
 - ii. Power lines Down
 - iii. Smell of Gas in an Area
 - iv. Vehicle Fire Off the Roadway
 - v. Pet Locked in a Vehicle
 - vi. Vehicle Locked and Motor Running
 - vii. Carbon Monoxide Detector Activation
 - viii. Smoke Detector Activation with Nothing Showing
 - ix. Miscellaneous Hazardous Condition
 - x. Smell of Gas in a Structure
 - xi. Residential Fire Alarms
9. The following calls will be originally dispatched as a Special Assignment with an Engine and Brush 121:
 - i. Grass fire off the roadway
 - ii. Grass fire on the roadway (TIMS consideration as needed)
10. The following calls will originally be dispatched as a Special Assignment with an engine and MICU (a truck can be used if an engine is not available):
 - i. Medical Emergency
 - ii. Medical Alarm
 - iii. Child Locked in a Vehicle
 - iv. Public Assist Involving Moving a Patient
 - v. Public Assist Involving a Fall
11. The following calls will originally be dispatched as a Special Assignment with 1 engine and 1 truck (2 engines can be used if a truck is not available):
 - i. Vehicle Fire on the Roadway
 - ii. Commercial Fire Alarm with Single Activations
 - iii. Water Vac
 - iv. Elevator Rescue
12. The following calls will originally be dispatched as a Special Assignment with an engine and medic (Responding as the Rescue), a truck, and a chief officer:
 - A) Technical Rescue Outside of the City
13. The following calls will originally be dispatched as a Special Assignment with an engine, a truck, MICU and a chief officer (a second engine can be used if a truck is not available):
 - i. Motor Vehicle Accident with Injuries (or Pin-In)
 - ii. Medical Emergency in the Roadway
 - iii. Public Assist Involving Entrapment

14. The following calls will originally be dispatched as a Full Assignment with 3 Engines, 1 Truck, 3 MICUs and a Chief Officer:
 - i. Structure Fire
 - ii. Dumpster Fire Against a Structure
 - iii. Vehicle Fire Against a Structure
 - iv. Grass Fire Impinging on a Structure
 - v. Technical Rescue in the City
 - vi. Visible Smoke in a Structure
 - vii. Commercial Fire Alarms with Multiple Activations
 - viii. Any fire alarm in a school or daycare (during class hours)
 - ix. Any fire alarm to a nursing home or hospital facility
